  - enterprise architecture system or solution (e.g. TOGAF).
- (e) Strong leadership, interpersonal and communications skills with strong analytical, problem solving and self-motivation in driving developments; and
- (f) Good command of spoken and written English and Chinese.

**Employment Terms:** The remuneration package will be commensurate with qualifications and experience.
