Dear Principal,

Streamlining of the School-based Assessment (SBA) Requirements for the 2021 HKDSE

I write to update you on the following regarding the conduct of School-based Assessment (SBA) in the 2021 Hong Kong Diploma of Secondary Education Examination (HKDSE).

1. Streamlining of the SBA requirements for the 2021 HKDSE

Due to the impact of the Novel Coronavirus (COVID-19) infection, the Hong Kong Examinations and Assessment Authority (HKEAA) has reviewed the SBA requirements for students entering the 2021 HKDSE to facilitate schools and students to complete the SBA in time. Currently there is a set of SBA requirements for S6 school repeaters/transfer students who complete the SBA task(s) in the S6 year only. Since schools and teachers are familiar with the existing requirements for S6 school repeaters/transfer students, these have been used as an overarching principle, applicable to all subjects, for the review.

- In ten subjects, the SBA requirements for the 2021 HKDSE cohort are streamlined by reducing the number of assessment tasks to be completed. Reference have been made to the SBA requirements of S6 school repeaters/transfer students.
- No proposed changes are made for the remaining four subjects, as the SBA requires students to complete one task only.

The **Annex** summarises the changes, if any, to the SBA requirements for the cohort. For the details of the streamlining, please refer to the revised Assessment Frameworks and the SBA Teachers' Handbooks of the ten subjects with streamlining. 2. SBA Mark Templates for 2021 HKDSE

Schools are required to submit all SBA marks to the HKEAA in one go in S6. To facilitate schools to store the SBA marks, SBA Mark Templates (in the format of MS Excel files) are prepared for teachers to input the SBA marks for internal record-keeping. Compared to the original 2021 SBA Mark Templates, the templates for the ten subjects with streamlining for the 2021 cohort are revised. The templates for all the 14 subjects with an SBA component are available on the following web pages:

As information like candidate numbers are not yet available for the time being, the SBA Mark Templates only serve to facilitate schools to input their SBA marks for internal record-keeping but not for submission purpose in S6. Schools are free to adapt these Mark Templates or use other suitable means to keep their SBA marks safely for submission in S6.

3. S5 SBA Teacher Documents for 2021 HKDSE (for Biology, Chemistry, Physics, Combined Science (CS) and Integrated Science only)

In connection to the streamlining of the SBA requirements for the 2021 cohort, **teachers of the above subjects are NOT required to submit the relevant Teacher Documents of their S5 classes in the 2019-20 school year.** The Teacher Documents of the above subjects are to be submitted together with the SBA marks to the HKEAA in one go in S6. Details of the submission requirement are listed below for easy reference.
