**Hong Kong Diploma of Secondary Education Examination (HKDSE)
Arrangements for Release of Results and Rechecking & Remarking Applications for 2016
HKDSE and June Registration for 2017 HKDSE**

Following the smooth conduct of the 2016 HKDSE, a briefing session will be held **at Ho Lap College (Sponsored By The Sik Sik Yuen) on Friday, 24 June 2016 from 2:00 pm to 5:00 pm.** The briefing session will cover the procedures and use of the related application systems for the following important post-examination activities as well as the June Registration for the 2017 HKDSE. The rundown is given in *Annex I*.

Release of Results

The results for the 2016 HKDSE Categories A and B subjects will be released **on Wednesday, 13 July 2016** and the Category C subjects (Other Languages - June 2016 Series) **on Wednesday, 10 August 2016.**

Application for Rechecking and Remarking

(i) For Category A and B subjects

Applications for rechecking and/or remarking of Categories A and B subjects will be accepted **from 13 July to 18 July 2016.** During the application period, schools are requested to submit online applications on behalf of their candidates via the **Rechecking and Remarking Application (RRA) System.** Tentatively, the results of rechecking and remarking are scheduled to be released on Wednesday, 10 August 2016.

(ii) For Category C subjects

Applications for rechecking and/or remarking of Category C subjects (Other Languages – June 2016 Series) will be accepted **from 10 August to 15 August 2016.** Schools should submit application forms for their candidates at the HKEAA Southern Centre office. Online submission will **not** be available. The release of rechecking and remarking results for Category C subjects (Other Languages – June 2016 Series) is subject to confirmation by Cambridge International Examinations (CIE).

2017 HKDSE – June Registration and Application for Special Examination Arrangements

Registration for the Category C subjects (Other Languages – November 2016 Series) of the 2017 HKDSE will be accepted **from 15 June to 11 July 2016.** Schools are invited to submit their students' subject entries for the Examination via the Registration System during the aforementioned period. Applications for special examination arrangements (SEA) for SEN students sitting the Category C subjects (Other Languages - November 2016 Series) examination will also be accepted at the same time, i.e. from 15 June to 11 July 2016.

Details of the application procedures are promulgated in the Examination Circular No. (10) dated 1 June 2016.

School principals and School Examination Officers (SEO) are cordially invited to attend the aforementioned briefing session. To facilitate our logistics arrangements, please sign up for the briefing **via the School Information Management (SIM) System (*Login HKDSE Examination Online Services → School Information Management → Maintain → Register Event*) on or before 21 June 2016 (Tuesday)**. Due to limited seating capacity, each school may nominate up to two representatives to attend the briefing session. The presentation materials will be uploaded to the main page of the relevant systems of the HKDSE Examination Online Services and the “Schools and Teachers” corner of the HKEAA website on 27 June 2016.
