Please be informed that a briefing session will be held **on Wednesday, 27 June 2018 from 2:00 pm to 5:00 pm at Concordia Lutheran School (Address: 12 Tai Hang Tung Road, Kowloon)**. The briefing session will cover the procedures and use of related application systems for the post-examination activities of the 2018 HKDSE, as well as the arrangements for June Registration for the 2019 HKDSE. The rundown of the briefing is given in *Annex 1*.

2018 HKDSE Post-examination activities

(a) Release of Results

The results for the 2018 HKDSE Categories A and B subjects will be released **on Wednesday, 11 July 2018**. Starting from 2018, the password slips will be disseminated to schools in both hardcopy and electronic form on the results release day.

(b) Applications for Rechecking and Remarking for Categories A and B Subjects

Applications for rechecking and/or remarking of Categories A and B subjects will be accepted **from 11 July to 16 July 2018**. During the application period, schools are requested to submit online applications on behalf of their candidates via the **Rechecking and Remarking Application (RRA) System**. Tentatively, the results of rechecking and remarking are scheduled to be released on 8 August 2018.

2019 HKDSE – June Registration and Application for Special Examination Arrangements

Registration for the Category C (Other Languages) subjects of the 2019 HKDSE (i.e. November 2018 series) will be accepted **from 20 June to 9 July 2018**. SEN students requiring special examination arrangements (SEA) in the Category C subject examinations should submit their applications during the aforesaid period.

Details of the application procedures will be promulgated in the Examination Circular No. (10) which will be issued to schools shortly. *[Remark: School briefings regarding the September Registration will be held around mid to late September 2018. Details will be announced in early September.]*

School principals and School Examination Officers (SEO) are cordially invited to attend the briefing session. To facilitate our logistic arrangements, please sign up for the briefing **via the School Information Management (SIM) System (Login HKDSE Examination Online Services → School Information Management → Maintain → Register Event) on or before 25 June 2018**. Due to limited seating capacity, each school may nominate up to two representatives to attend the briefing session.
