Hong Kong Diploma of Secondary Education Examination Examination Circular No. (3) 2018/2019 Collection of 2018 Examination Certificates

- School principals are requested to send a member of staff to collect the 2018 Hong Kong Diploma of Secondary Education Examination certificates for their candidates from the Authority's Southorn Centre office (Address: 12/F, Southorn Centre, 130 Hennessy Road, Wan Chai, Hong Kong) during office hours (Monday to Friday: 8:30 am - 5:30 pm) between 22 and 26 October 2018, bringing the attached collection slip duly completed.
- 2. The certificates are arranged in Candidates' Reference Number order. Candidates who were absent from all subjects or whose results in all subjects are 'Unclassified'/'Unattained'/'Ungraded' will not be given a certificate.
- 3. To facilitate schools in recording the distribution of certificates to candidates, the Authority will provide each school with a computer-print document (*Specimen 1*), which lists the particulars of the candidates in Reference Number order. The document will be distributed to schools together with the certificates. Candidates should fill out the serial numbers of their certificates on the document and sign on the appropriate space to acknowledge receipt. This document is to be kept by the school and it does not need to be returned to the Authority.
- 4. School principals are requested to distribute the certificates to their candidates as soon as possible and advise them to check their personal data (such as Chinese/English name and identification document number) on the certificates. Should amendments be necessary, candidates should complete the amendment request form (*Specimen 2*) and return it together with the certificate to the Authority's Southorn Centre office as soon as possible. Candidates may request amendments through an authorised person who should submit a photocopy of the candidate's identification document. Amendment of personal data on the certificate will be made by the Authority free of charge if the request is received on or before 31 December 2018. For requests made between 1 January 2019 and 31 March 2019, a fee of HK\$248 will be charged. No amendment of personal data on the certificate will be accepted after 31 March 2019.
- 5. If a candidate loses his/her certificate or wishes to amend his/her personal data after 31 March 2019, he/she may apply for a Statement of Results from the Authority. The current fee for the issue of a Statement of Results is HK\$490 per copy.
- 6. School principals are required to return all unclaimed 2018 certificates to the Authority at the time when certificates for the next Examination (i.e. 2019 Examination) are collected.
