Hong Kong Diploma of Secondary Education (HKDSE) Examination Milestone Plan for 2013 Examination

I am enclosing the milestone plan for the 2013 HKDSE Examination for your reference. Your attention is drawn in particular to the administrative arrangements for the examination in the following areas:

- (a) The September registration for Category A, Category B and Category C (Other Languages June 2013 Series) subjects will be accepted via the HKDSE Examination Registration System from 19 September to 11 October 2012. Details are promulgated in the Examination Circular No. (2) dated 7 September 2012.
- (b) Applications for special examination arrangements for candidates with special needs sitting the 2013 and 2014 examinations are being accepted via the SEA Online Services from 5 to 24 September 2012.
- (c) To facilitate the HKEAA in arranging examination accommodation for the 2013 HKDSE Examination, schools will be requested to update the school information and facilities, and to confirm the availability of their examination venues for the conduct of the written and speaking examinations through the Examination Centre Management (ECM) System from 19 September to 28 September 2012.
- (d) Submission of the School-based Assessment (SBA) marks and samples of students' work for Secondary 6 students will take place from December 2012 to March 2013. The submission of SBA marks for Secondary 5 students will take place from May to July 2013. SBA Teachers' Conferences for the 12 subjects with SBA in 2013 HKDSE Examination will be held from October to November 2012.

In view of the positive feedback from schools on the 2012 HKDSE practice papers, the HKEAA has decided to produce the practice papers for Liberal Studies for the 2013 HKDSE cohort. After consultations with the Advisory Committee on Public Examinations Administration (comprising school principals and school teachers), it has been agreed that the Liberal Studies practice papers will be provided in electronic form and be uploaded to the HKDSE Examination Online Services at https://www.hkdse.hkeaa.edu.hk. Principals and School Examination Officers can login their designated user account to access and download the practice papers on 13 December 2012 and the marking schemes on 17 December 2012. The Authority will also arrange seminars for schools to learn how to set question papers and marking guidelines.
