The Hong Kong Examinations and Assessment Authority (HKEAA) offers a wide range of assessment services through its International and Professional Examinations Division (IPED) for approximately 120 organisations which include government departments, public organisations, licensing authorities, professional bodies, examination boards, awarding bodies, schools, colleges and universities from all over the world. About 300,000 candidates make use of these services each year.

## **Range of Services**

Most of the assessment services offered by the Authority are tailored to the needs of the commissioning organisations. Major service areas include:

#### **Pre-examination Services**

- Production of examination stationery, such as answer books and attendance dockets, etc.
- Secure printing of question papers
- Hiring examination venues
- Issuing admission forms

#### **Conduct of Examination**

- · Appointment and training of invigilation personnel
- Conduct of examination
- Making arrangements for candidates with special needs
- Handling of examination irregularities

#### **Post-examination Services**

- Checking and return of examination materials to examination bodies
- · Compilation of examination reports
- Shredding and destruction of examination materials as instructed by the examination bodies
- Organising the marking of answer scripts and coursework
- · Scanning of multiple-choice answer sheets
- Issuing results documents
- Printing of certificates
- Certification of examination results

#### **Examination Support Services**

- Provision of professional advice on the development and administration of examinations
- Development of examination related computer application systems
- Statistical analyses of examination results
- Organising promotional activities for examinations on behalf of or jointly with the associating examination bodies, such as press conferences, press interviews, awards presentations and seminars, etc.
- Sale of examination publications via counters and HKEAA Online Bookstore
- Distribution of publicity materials by post or via counters
- Secure storage of examination materials, such as question papers and worked scripts, etc.
