## 2.2 Registration:

#### (a) By Post

Applicants may submit by mail with (i) a completed entry form; (ii) an examination fee payment receipt issued by 7-Eleven or Circle K convenience stores; and (iii) a photocopy of his/her H.K. Identity Card or Passport (which will be destroyed after checking and verification of entry data) to the HKEAA (address: 3/F, 17 Tseuk Luk Street, San Po Kong, Kowloon) on or before 25 April 2017.

Applicants who do not receive an acknowledgement by 29 April 2017 should immediately contact the International and Professional Examinations Division of the HKEAA on 3628 8731.

### (b) In Person / through a Representative:

Applicants may submit (i) a completed entry form; and (ii) an examination fee payment receipt issued by 7-Eleven or Circle K convenience stores to the registration centre in person during the following period (H.K. Identity Card or Passport will be checked at the time of registration).
