Dear Principal

Hong Kong Diploma of Secondary Education Examination 2012 Release of Rechecking / Remarking Results

- 1. The results of rechecking and remarking will be released on **Monday**, **20 August 2012**. I should be grateful if you would send a member of your staff to collect the following documents from the Authority's Wan Chai office (address: 12/F, Southorn Centre, 130 Hennessy Road, Wan Chai) during office hours (8:30 am 5:00 pm) on that day. Your staff member should bring along the collection slip (copy attached) duly completed while collecting the documents:
 - (a) Rechecking / Remarking Results List;
 - (b) Notification letters to individual candidates who have applied for rechecking / remarking;
 - (c) Explanatory Notes on Rechecking and Remarking in the 2012 HKDSE Examination (one copy per candidate).
- 2. The notification letters should be distributed to individual candidates together with the Explanatory Notes on Rechecking and Remarking in the 2012 HKDSE Examination without delay. For subjects with subject / component results being upgraded, arrangements will be made for the revised results to be incorporated in the certificates to be issued to candidates in October 2012. The Authority will also inform the JUPAS office of the revised results with subject upgrade at the same time.
- 3. Schools may download the updated results file from the HKDSE Examination Online Services (https://www.hkdse.hkeaa.edu.hk) or WebSAMS (if applicable) from 8:30 am on 20 August 2012, using the same password provided to schools for accessing the examination results on 20 July 2012. In addition to the three files viz. Results Data File, School Results List and Analysis of School Results, a new report "Results Change Summary" will also be provided. Evening school candidates may also view their rechecking / remarking results through the Online Enquiry of Results Service (https://www.hkdse.hkeaa.edu.hk/RD/result.jsf) from 8:30 am on 20 August 2012 by using the same login password for viewing their examination results online. The online service will be available till 9 September 2012 (Sunday).
- 4. The Authority will arrange refund of the rechecking / remarking fees to the candidates with upgraded results. The refund cheques will be mailed to them within two weeks from the date of release of rechecking / remarking results. School principals are requested to inform the candidates about this arrangement.



Appeal Review

5. Candidates who wish to request a review of the process of rechecking and remarking should submit their applications in writing giving reasons and justifications to substantiate the request. A support letter from the school is **not** required. The appeal review application together with the required fee of HK\$759 (per subject) must be submitted to the HKEAA on or before the closing date of **Monday, 27 August 2012**. Details are given in Part 4 of Section E of the 2012 HKDSE Handbook for Candidates.

Bad Weather Arrangements

6. Schools are requested to note the contingency arrangements for bad weather as follows:

If Typhoon signal No. 8 is hoisted or Black rainstorm warning is issued at or before 5:00 am on Monday, 20 August 2012, the release of rechecking / remarking results to schools will be postponed.

If Typhoon signal No. 8 or Black rainstorm warning is lowered at or before 1:00 pm, the Authority will resume its operation immediately. Schools may send their staff to collect the Results List from the Authority's Wan Chai office two hours after the signal is cancelled.

If Typhoon signal No. 8 or Black rainstorm warning is lowered after 1:00 pm, the release of rechecking / remarking results to schools will be postponed by one day (i.e. the results will be released on Tuesday, 21 August 2012).

Under the above circumstances, schools and candidates are advised to listen to the radio, watch the television or check out the HKEAA website (www.hkeaa.edu.hk) for the Authority's announcement.

2012 年香港中學文憑考試 覆核成績安排

積分覆核及重閱答卷程序

注意:

- 1. 本文件中所提及的政策及程序只適用於甲類(新高中)及乙類(應用學習)科目。丙類(其他語言) 科目之積分覆核及重閱答卷程序則根據英國劍橋國際考試部的既定程序處理。
- 2. 重閱答卷不適用於下列科目/卷別:
 - 乙類科目;
 - 校本評核卷別、多項選擇題卷別、甲類科目之實習試;及
 - 丙類科目之說話能力部分。

積分覆核

- (1) 積分覆核之申請以每科爲單位。覆檢有關科目的答卷及記分紙是否計算無誤,分數是否已準確地輸入電腦系統,以及答卷內每頁答案是否已經評閱。
- (2) 若在積分覆核過程中發現技術錯誤而成績有所修訂,考生會獲發經修訂後的成積,並獲退還考生就該 科目已繳付的費用。

重閱答卷

(3) 就以下甲類科目,考生可申請重閱全科或分部之答卷: 中國語文科/英國語文科/組合科學

注意:中國語文科及英國語文科的整科重閱答卷申請只包括筆試答卷。重新評核已錄影的口試部分則 需另行申請。

- (4) 除上述科目外,其他甲類科目的申請均以每科爲單位。
- (5) 在覆核過程中,所有答卷會經由獨立閱卷員按照以下程序重新評核:
 - i. 每份答卷及記分紙(適用於口試)會先經積分覆核,以排除技術上的錯誤;
 - ii. 每份答卷會經由一名覆核閱卷員重新評閱,若評分與原來所獲分數有分別,則答卷再交第二名覆核閱卷員重新評核;
 - iii. 至於採用「雙評制」的卷別,即在成績發放前已經由兩名閱卷員評核的筆試答卷,若重閱答卷的 評分與原先評分的差距超出指定幅度,答卷會再由第二名覆核閱卷員重新評核;
 - iv. 就重新評核口試成績,有關考生的口試錄影只會由一名口試主考員重新評核。

考評局盡力確保筆試答卷及口試的覆核,不會交由原來的閱卷員/口試主考員負責。

- (6) 重閱答卷後的評分會被納入有效分數之列(包括原先的閱卷員及覆核閱卷員所給予的所有評分),以其 平均值計算考生最終的科目/卷別成績。
- (7) 經過重閱答卷而決定分數後,其他在原來分數上的扣減/提升亦同時適用於最終的分數上。
- (8) 考生申請重閱全科答卷,所有非口試部分均會重新評核,而重閱後所得之分數會用作最終科目/分部 等級成績計算之用。
- (9) 考生申請重閱分部答卷,有關分部之答卷及/記分紙會被重新評核,而重閱後所得之分數會用作最終 科目/分部等級成績計算之用。
- (10) 重閱試卷適用於由考評局評閱(並非由考生的科目老師評閱)的閱讀報告、作業、研究報告或作品集。 有關科目包括:
 - 英語文學科卷三
 - 音樂科卷三、卷四及卷六
 - 視覺藝術科作品集(只適用於自修生)

積分覆核及重閱答卷的結果

積分覆核及重閱答卷後的成績

完成積分覆核/重閱答卷程序後,考評局的專責委員會(由秘書長擔任主席)會審視所有申請,並按 照「公開考試委員會」所訂定提升成績等級的準則,決定個別申請是否符合有關準則。

- 積分覆核後如發現技術錯誤,科目/分部的積分經修正後若達到上一個等級的最低分數,有關成績將 會獲得提升。
- (13) 重閱答卷後的科目/分部積分與上一個等級的最低分數相比,如高出按照「公開考試委員會」規定爲該科特定的分數,等級方會獲得提升(註:新積分是原來閱卷員及覆核閱卷員所給有效分數的平均值)。 由於閱卷工作涉及專業判斷,尤其是開放式題目,即使由同一位閱卷員重閱同一份答卷,分數亦可能 有些微差別。
- 若覆核的科目成績/分部等級獲得提升,考評局會把已修正之成績列於今年十月發出之證書上。如考 生希望在現時更新考試成績通知書,可攜同原本之成績通知書到本局辦理。
- (15) 考評局會同時將成績獲提升的考生名單通知大學聯合招生處。

退還費用

- 若考生的一個或多於一個分部成績經積分覆核/重閱答卷後有所修訂,或科目的成績有所提升,考生 就該科目已繳付相應之部分覆核費用(如適用)會按下列指引退還:
 - 若積分覆核後,考生的科目或分部成績獲得提升,會獲退還有關科目的積分覆核費用;
 - 若考生申請重閱全科答卷,而分部成績經重閱答卷後獲得提升,科目成績則維持不變,會獲退還 有關分部的重閱答卷費用;
 - iii. 若考生申請重閱某一科的一個或多於一個特定分部的答卷,會獲退還有關獲得分部提升的重閱答
 - iv. 若考生申請重閱答卷,而科目成績經重閱答卷後獲得提升,會獲退還考生爲該科目所繳付的重閱 答卷費用;及
 - 在任何情況下,退款的總額不會超出考生爲該科目已繳付的積分覆核/重閱答卷費用。
- 經積分覆核/重閱答卷後,若考生的分部/科目成績獲得提升,考評局會於覆核成績結果通知書發出 的兩星期內郵寄支票退還有關費用。有關支票必須於六個月內存入户口或於任何一間恆生銀行分行提 (17)取現金。

- <u>一經重閱答卷後,若科目或分部成績維持不變,考評局已就有關申請進行以下程序:</u>
 - 經積分覆核後,已確定沒有出現技術錯誤(即答案或記分紙的分題得分及總分沒有計算無誤,分 數已準確地輸入電腦系統);

 - ii. 覆核閱卷員所給予之分數與原來閱卷員的分數相若;及 iii. 重閱答卷後,成績已經過考評局的專責委員會(由秘書長擔任主席)審視及確認。

積分覆核/重閱答卷後,科目成績涌常不會被降級。

上訴覆核

- 於重閱答卷/積分覆核的過程中,答卷會被獨立及全面地重閱/覆核,以確定評分沒有出錯。然而, 個別考生如對積分覆核/重閱答卷的程序仍有存疑,可於積分覆核/重閱答卷結果公佈後 7 天內申請 上訴覆核。申請手續可參閱考生手冊及考評局網頁。有關個案將由獨立的「上訴覆核委員會」處理, 所有未能於截止日期前遞交的上訴覆核申請將不獲處理。而「上訴覆核委員會」的決定是個案的最終 決定。
- (21) 丙類科目的上訴覆核申請會交由英國劍橋國際考試部按其既定程序及日期處理。英國劍橋國際考試部 作出的決定是個案的最終決定。
