### Hong Kong Examinations and Assessment Authority Examination Circular No. (3) 2012 / 2013 Applications for Examination Fee Remission in HKDSE Examination

### 1. Eligibility Criteria

Students who pass the means test of the Student Financial Assistance Agency (SFAA) are eligible to apply for Examination Fee Remission (EFR) for the 2013 Hong Kong Diploma of Secondary Education (HKDSE) Examination.

Student-applicants who are recipients of School Textbook Assistance (TA) in the last school year and have submitted the 2012 / 2013 "Application for Assessment of Eligibility for Primary and Secondary Students (Form B)" together with the "Application for Financial Assistance Scheme(s) (Form R)" to the SFAA will receive "Notification of Result on Assessment of Eligibility" (notification letter) (see specimen of this green letter) from the SFAA, provided they pass the means test. Other students who apply for student financial assistance from the SFAA and pass the means test will receive an Eligibility Certificate (EC) (see specimen of this pink form) issued by the SFAA.

Both the notification letter and EC will indicate the assistance level the student is entitled to and the effective date of assistance. EFR will be granted to eligible candidates sitting for the HKDSE Examination if the following criteria are met:

#### (1) The candidate is:

- (i) a Senior Secondary 3 full-time day school student who sits for the HKDSE Examination as a school candidate in 2013; or
- (ii) an adult learner who attends Secondary 6 / Senior Secondary 3 evening courses in designated centres that are quality-assured and commissioned by the Education Bureau (EDB), and is sitting for the HKDSE Examination as a school candidate in 2013; or
- (iii) a candidate who is sitting for the HKDSE Examination for the **second** time as a school candidate in 2013, provided that he/she has sat for the HKDSE Examination for the first time<sup>1</sup> in 2012 as a school candidate.
- (2) (i) Candidates whose "Eligibility Level" for student finance has been assessed as "Full" (eligible for full waiver) or "Half" (eligible for half EFR) by the SFAA; or

Under the HKDSE Examination, the examinations of 4 core and 24 elective New Senior Secondary subjects will take place from March to May each year and the internal assessments of Applied Learning subjects will also be completed by then. The examinations of the six Other Language subjects will take place in June and/or November of the preceding year according to the timetable of the Cambridge International Examinations. Examinations taken from March to June and November of the preceding year under the HKDSE Examination will be considered to be taken in the same examination year and therefore counted altogether as one examination entry for the purpose of EFR.

- (ii) Candidates who are recommended for "Full" or "Half" grant of TA by the attending school (only applicable to government, aided, per caput grant secondary day schools and local private day schools under the Direct Subsidy Scheme).
- (3) Candidates must apply for EFR through the Hong Kong Examinations and Assessment Authority (HKEAA).
- (4) The effective date for financial assistance as listed on the notification letters / EC is on or before **11 October 2012** (i.e. the registration closing date for the HKDSE Examination). For 'late applications' received after 11 October 2012, candidates must pay the full examination fees. Refunds will be arranged by the HKEAA around February 2013, after confirmation of their eligibility by the SFAA.

Students entering the HKDSE Examination as private candidates or studying in evening schools (except the EDB designated centres mentioned in (1) above are ineligible to apply for EFR.

### 2. Application Procedures

- (1) School principals are requested to:
  - (a) inform all eligible candidates who are sitting for the HKDSE Examination to apply for EFR at the time of registration, including those who have registered for the Category C Other Languages subject examinations for November 2012 under the HKDSE Examination.
  - (b) refer to the Result Data Files for Student Finance transmitted to the schools by the SFAA from mid August 2012 or School Textbook Assistance / Student Travel Subsidy (TA / STS) Report issued by the SFAA to the eligible student-applicants from late August 2012 to ascertain their eligibility as mentioned in paragraph 1 and submit EFR application for them. It is strongly advised that all relevant data (including the list of eligible candidates and their level of assistance) be checked carefully before submission of application for EFR.

### Method of application for EFR

Schools should apply for EFR for the eligible candidates via the HKDSE Examination Registration System:

- (i) Schools using WebSAMS should import the result data file via the CDS to the SFAA module in WebSAMS and confirm the application for examination fee remission in the HKEAA module before transmitting the entry data to the Registration System. Any changes in the level of assistance before the closing of September Registration can be made in individual candidates' records or through the "Group Update" function in the Registration System.
- (ii) Schools not using WebSAMS may **either** indicate the level of assistance "100" ("Full" assistance level), "50" ("Half" assistance level) or "0" (No remission) for the candidates in their data file before uploading the data to the Registration System **or** input the level of assistance through the "Group Update" function or in the individual candidates' records in the Registration System.
- (c) make sure that the HKID card no. of the candidate has been printed / put down on the EC before submitting it to the SFAA and a photocopy is made for the school's future reference.

- Students receiving "Full" level of assistance need not pay the examination fees while those receiving "Half" level of assistance will need to pay half of the examination fees at the time of registration. Apart from candidates mentioned in paragraph 1(4) above who will be refunded the examination fees (including those for Category C subjects) around February 2013, the HKEAA will arrange refunds of the examination fees for the Category C subjects under the HKDSE Examination to candidates, who have already paid the examination fees for this subject during registration in June/July 2012, around December 2012.
- (3) The HKEAA will inform schools of the outcome of the EFR applications around January 2013, upon confirmation of the candidates' eligibility by the SFAA.

# 3. Procedures for Handling Additional EFR Applications or Adjustment of Assistance Level after Submission of Entries

(1) After the submission of examination entries, schools will receive TA / STS Result data file from the SFAA via CDS or notification letter / late EC submitted by eligible candidates. These reports / documents will inform schools of additional applications required or adjustment of candidates' assistance level. Schools should follow up with the candidates who have become eligible for EFR. Schools should make use of the attached DSE13 form "Examination Fee Remission – Additional Application" to submit applications for the eligible candidates as mentioned in paragraph 1.

**Additional EFR application**: Candidates must pay the full examination fees. Refunds will be arranged by the HKEAA around February 2013, after confirmation of their eligibility by the SFAA.

**Adjustment of assistance level**: All over-paid and under-paid cases will be handled by the HKEAA around February 2013, after confirmation of the candidates' eligibility by the SFAA. In this connection, schools need NOT inform HKEAA of the adjustment of assistance level of their candidates.

(2) Schools should note and inform candidates who wish to apply for EFR that additional EFR applications should be submitted on or before 7 December 2012, or within 1 month after the issue of the EC (or notification of assistance level adjustment), whichever is later. Late additional EFR applications will normally not be accepted.

#### 4. Other Points to Note

- (1) Families in receipt of Comprehensive Social Security Assistance (CSSA) should apply directly to the Social Welfare Department for assistance towards their children's examination fees.
- (2) School principals are requested to notify the HKEAA immediately if any of the EFR applicants has left the school or withdrawn from the HKDSE Examination.
- (3) For EFR applicants who wish to add or change a subject after the submission of examination entries, if the requests are made on or before 7 December 2012, candidates who are eligible for "full" assistance level should pay the supplementary fee for substitution/addition of subjects only. Candidates who are eligible for "half" assistance level should pay the supplementary fee for substitution/addition of subjects and half amount of the total subject fees (including all the additional subject fees / difference in subject fees). If the requests are made between 8 and 21 December 2012, all candidates should be responsible for paying the supplementary fees and the subject fees incurred.

- (4) If an EFR applicant is subsequently found ineligible after submitting his / her application, he / she will be required to pay the full amount of the examination fee to the HKEAA / SFAA. Pursuant to Clause 5.9 of 2013 HKDSE Examination Regulations, entries of candidates will not be regarded as having been accepted until the fees payable have been received in full by the Authority. As such, candidates' applications for 2013 HKDSE Examination will be cancelled if they fail to pay the full amount of the examination fee. No admission form will be issued to the candidates concerned.

Please note that the SFAA will conduct post-payment authentication on the applications, including home visits, random checking, and data matching with the Social Welfare Department. If the findings are different from the initial assessment result, the SFAA will adjust the level and hence the amount of assistance granted to you.

If you are dissatisfied with the assessment result, you may apply in writing to the Financial Assistance for Primary and Secondary Students Section of this Agency for re-assessment, specifying in the written request the application number or the HKID card number of the applicant, providing detailed justifications and any documentary evidence in support of your application. The application for re-assessment must be duly signed by the applicant. Re-assessment of eligibility normally takes three months to process. Since longer processing time will be needed for re-assessment, applicant should apply for re-assessment promptly within one month from the issue date of the notification of result.
