**Hong Kong Diploma of Secondary Education (HKDSE) Examination 2022  
Administrative Arrangements for Music**

I would like to draw your attention to the administrative arrangements regarding the submission of performance recordings/portfolios/project reports for the 2022 HKDSE Music examination.

Refer to the examination circular No. (13) 2020/2021 regarding the streamlining of the practical examinations of Physical Education and Music. Music Paper 2 will be cancelled for the 2022 HKDSE Music examination.

In view of the impact of the pandemic, the Authority has decided to postpone the deadline for the update of evidence of qualifications to **31 January 2022**. This is a one-off supporting measure to help the Music candidates who are being affected by the cancellation of the international examinations scheduled for 2021.

Details of the submission schedule and a checklist of the items to be submitted for Papers 3 to 4C are attached for your information. The tentative practical examination period for Paper 4B is also enclosed. Further details of the Music practical examination and submission guidelines for Papers 3 to 4C will be announced on the HKEAA website in due course. Kindly draw the attention of your teacher(s) concerned to this matter.
