**Hong Kong Diploma of Secondary Education Examination (HKDSE)  
Arrangements for Release of Results and Rechecking & Remarking Applications for 2017  
HKDSE**

Please be informed that a briefing for schools will be held at **Concordia Lutheran School on Friday, 23 June 2017 from 2:00 pm to 5:00 pm**. The briefing session will cover the procedures and use of the related application systems for the following post-examination activities as well as the June Registration for the 2018 HKDSE. The rundown of the briefing is given in *Annex 1*.

**Release of Results**

The results for the 2017 HKDSE Categories A and B subjects will be released **on Wednesday, 12 July 2017** and the Category C subjects (Other Languages - June 2017 Series) **on Monday, 14 August 2017 (tentative)**.

**Application for Rechecking and Remarking**

(i) For Category A and B subjects

Applications for rechecking and/or remarking of Categories A and B subjects will be accepted **from 12 July to 17 July 2017**. During the application period, schools are requested to submit online applications on behalf of their candidates via the **Rechecking and Remarking Application (RRA) System**. Tentatively, the results of rechecking and remarking are scheduled to be released on Wednesday, 9 August 2017.

(ii) For Category C subjects

The application period for rechecking and/or remarking of Category C subjects (Other Languages – June 2017 Series) will be accepted within 5 calendar days after the release of results; the exact date will be announced in due course. Schools should submit application forms for their candidates at the HKEAA Southern Centre office by the specified deadline. Online applications will **not** be available. The release of rechecking and remarking results for Category C subjects (Other Languages – June 2017 Series) is subject to confirmation by Cambridge International Examinations (CIE).

**2018 HKDSE – June Registration and Application for Special Examination Arrangements**


Registration for the Category C subjects (Other Languages – November 2017 Series) of the 2018 HKDSE will be accepted **from 14 June to 10 July 2017**. SEN students requiring special examination arrangements (SEA) in the Category C subjects - November 2017 examinations should submit their applications during the same period.

Details of the application procedures are promulgated in the Examination Circular No. (10) dated 1 June 2017.

School principals and School Examination Officers (SEO) are cordially invited to attend the briefing session. To facilitate our logistic arrangements, please sign up for the briefing **via the School Information Management (SIM) System** (*Login HKDSE Examination Online Services → School Information Management → Maintain → Register Event*) **on or before 21 June 2017 (Wednesday)**. The presentation materials will be uploaded to the main page of the relevant systems of the HKDSE Examination Online Services and the “Schools and Teachers” corner of the HKEAA website **by 12:00 noon, 26 June 2017**.
