Hong Kong Diploma of Secondary Education (HKDSE) Examination Briefing Sessions on Practice Papers

Further to our earlier letter dated 21 December 2011 on the briefing sessions on Practice Papers for the first batch of subjects, I write to give you details about the briefing sessions on the practice papers for the remaining 16 subjects, which are scheduled to be held from mid February to early March 2012. The briefing sessions aim to provide subject teachers with the following information: the requirements of the practice papers, the marking criteria, students' general performance in the practice papers and samples of students' performance. These will be useful feedback to teachers and students in preparation for the 2012 HKDSE Examination.

In addition to the subject-specific sessions, I am pleased to inform you that two identical briefing sessions will also be organised for **school leaders**. These sessions aim to provide school leaders with feedback on the practice papers at a system level, and latest updates on the HKDSE and SBA developments. It would also serve as a good opportunity for enhancing our communication with schools to ensure the smooth delivery of the 2012 HKDSE Examination.
