

Hong Kong Diploma of Secondary Education Examination (HKDSE) 2021
Registration for Category C (Other Languages) Subjects (i.e. November 2020 series)
Information Sheet for Checking of Candidate Entry Information Checklist (CEIC)

1. Before confirming the submission of their registration entry to the HKEAA via the HKDSE Examination Registration System (the Registration System), candidates should carefully check all personal data and subject entry information on their CEIC to ensure that there are no errors in their entry. If they discover any errors, candidates should make the amendments online by logging into the Registration System using their login account.

2. **Information Printed on the CEIC**

| (1) Surname and Given Name | Candidates should carefully check the spelling of their surname and given name. |
| (2) Name in Chinese | <p>Candidates should check their Chinese name carefully particularly the Chinese characters such as 「群」 and 「羣」, 「峰」 and 「峯」, 「柏」 and 「栢」, 「強」 and 「强」. If candidates find any Chinese characters of their name incorrectly displayed on the CEIC, they should confirm the submission of their registration entry to the HKEAA via the Registration System first and then notify the HKEAA Public Examinations Information Centre immediately (<i>please refer to Paragraph 7 on page 2 for the contact details</i>). The candidates may be requested to provide a copy of their identification document for the HKEAA to rectify the incorrect display.</p> <p>The Chinese name shown on the CEIC must be identical with that on the identification document and it will be printed on the HKDSE certificate. For candidates who have not indicated their Chinese name, '---' will be printed in this column.</p> |
| (3) Name in English | Candidates should carefully check the spelling of their name which will be printed on their HKDSE certificate. |
| (4) ID Type & ID No. | <p>Candidates should carefully check their identification document type and number as the document number will be printed on their HKDSE certificate. If the candidate does not have a HKID Card, the name and number of the candidate's valid identification document will be indicated here.</p> <p>Note: Candidates should use the same identification document number for both the HKDSE registration and JUPAS/tertiary institution application (if applicable).</p> |
| (5) Date of Birth | (Day / Month / Year) |
| (6) Gender | M = Male, F = Female |
| (7) E-mail Address / SMS Phone Number | Candidates should carefully check their email address and/or SMS phone number printed on the CEIC. |

To facilitate the HKEAA in contacting candidates or disseminating important examination-related information to them via email or SMS in case of emergency, candidates should provide their email address (mandatory) and SMS phone number (optional). For candidates who have not provided their SMS phone number, '---' will be printed in this column.

| (8) Contact Phone Number | The contact phone number provided by the candidate is listed here. |
| (9) Address | The correspondence address provided by the candidate is listed here. Candidates should check their address carefully. The 'Instructions to Candidates' will be uploaded to the HKEAA website in mid-September 2020 for viewing by candidates. |
| (10) Examination Fee | The amount of examination fees and supplementary fee(s) (if applicable) is listed here. |
| (11) Subject(s) Entered | The name(s) of the subject(s) entered for Category C (Other Languages) subjects is/are listed here. |
| (12) Language Version | As Category C subjects provide one language version only, '---' will be printed in this column. |
| (13) No. of Subject(s) Entered | This refers to the total number of subject(s) for which the candidate has entered. |

3. Choice of Examination Centre District

The choice of examination centre district is not provided on the CEIC as it is not available for Category C (Other Languages) subjects.

4. Where No Amendments are Required

Candidates should check the information on their CEIC carefully. After confirming that all entry data on their CEIC are correct, candidates should confirm the submission of their registration entry to the HKEAA via the Registration System before the closing date of 23 July 2020 and keep their CEIC for reference.

5. Where Amendments are Required

If candidates discover any errors in their CEIC, they should make the amendments by logging into the Registration System using their login account. Candidates are advised to check their CEIC again carefully after amendments have been made. Where there are no errors in the entry, candidates should confirm and submit their online registration entry to the HKEAA before the closing date of 23 July 2020.

6. Amendment of Subject Entries

After candidates have confirmed and submitted their registration entry to the HKEAA, if they wish to apply for addition or substitution of subjects, their applications are subject to the approval of the HKEAA and payment of a supplementary fee (please refer to *Section J in the 'Instructions to Applicants (Private Candidates)'* for more details). The candidates concerned should submit a hard copy application form in person at the HKEAA Southern Centre office **during the amendment period (from 24 July to 5:30 pm, 6 August 2020)** and settle the relevant fees by credit card/EPS/Octopus (the ceiling of each transaction is HK\$3,000) at the time when the application is submitted or pay at any 7-Eleven or Circle-K Convenience Stores in Hong Kong before the specified deadline printed on the demand note.
