



## 關於文憑試 About the HKDSE

香港中學文憑是廣為本港及國際認可的學歷證明，為學生開拓多元出路。在香港，學生完成三年全日制高中課程後，可參加香港中學文憑考試（文憑試），成績符合要求的考生將獲發香港中學文憑證書。

Widely recognised both locally and internationally, the Hong Kong Diploma of Secondary Education Examination (HKDSE) is a credential preparing students for multiple pathways. In Hong Kong, students will take the HKDSE upon completion of a full-time three-year senior secondary curriculum. Candidates who have attained the required results will be awarded the HKDSE certificate.



# 報考文憑試 Registration for the HKDSE

## 報考資格 Entry Qualifications

### 學校考生 School Candidates

- ✎ 考生為已獲批准參加應屆文憑試之香港註冊學校或香港境外符合資格的學校之中六（或等同中六）正讀生；及  
Bona fide Secondary 6 (or Secondary 6 equivalent) students of registered schools in Hong Kong or qualified schools outside Hong Kong approved for participation in the HKDSE; and
- ✎ 在考評局所記錄該校之註冊地址上課。  
studying at the registered address of the schools as per HKEAA's record.

### 自修生 Private Candidates

但凡符合下列其中一項條件者，可以自修生身分參加文憑試：

A person may enter for the HKDSE as a private candidate provided he/she has satisfied one of the following requirements:

- ✎ 曾應考文憑試，或相等考試，或  
Sat the previous HKDSE or an equivalent examination, or
- ✎ 以考試年度的1月1日計算，已足19歲，或  
Reached the age of 19 by 1 January of the respective examination year, or
- ✎ 非修讀文憑試課程，但於考試前一年已修畢或正在修讀由考評局決定為等同中六之課程。  
Completed or is currently pursuing a non-HKDSE curriculum equivalent to Secondary 6 as determined by the HKEAA in the year preceding the examination.

# 特別考試安排

## Special Examination Arrangements

考評局為有特殊需要和有身體殘障的考生提供特別考試安排。有特殊學習障礙、肢體活動能力障礙、視障、聽障、語障或其他障礙的考生，可向考評局申請特別考試安排。我們會盡力讓有特殊需要的考生在適當的環境下應考，得到公平的評核，同時亦確保這些安排不會對其他考生造成不公平。

HKEAA provides special examination arrangements (SEA) for candidates with special needs and disabilities. Candidates with specific learning disabilities, physical, visual, aural, oral or other disabilities may apply for SEA. We strive to ensure that candidates with special needs are equitably assessed under suitable conditions without having an unfair advantage over other candidates.


### 申請辦法 Application

#### 學校考生 School Candidates

 可於考試年度前兩年的9月起，經學校遞交申請（即於中五學年的9月）。

Submit the applications in September two years before the examination year via their schools (i.e. in September of the S5 school year).

#### 自修生 Private Candidates

 須於考試年度前一年的申請期內遞交申請。

Submit applications during the application period in the year preceding the examination.

# 文憑試科目

## HKDSE Subjects

文憑試科目共分為三個類別，包括：

The HKDSE comprises three categories of subjects:

### 甲類 CATEGORY A

高中科目：包括四個核心科目（中國語文、英國語文、數學、公民與社會發展），以及多個選修科目

Senior Secondary subjects: including four core subjects (Chinese Language, English Language, Mathematics, Citizenship and Social Development) and various elective subjects

### 乙類 CATEGORY B

應用學習科目

Applied Learning subjects

### 丙類 CATEGORY C

其他語言科目：法語、德語、日語、西班牙語、印地語\*、烏爾都語^、韓語#

Other Languages subjects: French, German, Japanese, Spanish, Hindi\*, Urdu^, Korean# Languages

\* 適用至2024年文憑試。 Applicable until 2024 HKDSE.

# 由2025年文憑試起提供。 To be offered from 2025 HKDSE.

^ 烏爾都語考試將於2025年文憑試暫停舉辦。由2026年文憑試起，考生改為應考烏爾都語（國際）考試。

The Urdu Language examination will be suspended in the 2025 HKDSE. Starting from the 2026 HKDSE, candidates will be required to take the Urdu (International) examination.



# 文憑試評核要求

## Assessment of HKDSE Subjects

甲類  
CATEGORY A

### 高中科目 Senior Secondary Subjects

- ✎ 評核按各科的《課程及評估指引》與《評核大綱》制定。  
The assessment is conducted according to the *Curriculum and Assessment Guide* and the *Assessment Framework* of the respective subjects.
- ✎ 由考評局委任各科目/卷別的審題委員會擬定公開考試的試題及評卷參考。  
Moderation Committees of the subject/paper concerned, appointed by the HKEAA, are responsible for the development of question papers and marking schemes.

#### 校本評核 School-based Assessment

- ✎ 校本評核是指在日常學與教過程中，由學校任課教師來評核學生的表現。評核分數將計入考生的文憑試成績。  
School-based Assessment (SBA) refers to assessments administered in schools and marked by the students' own teachers. SBA scores awarded will count towards students' HKDSE results.
- ✎ 校本評核著重考核學生多方面的能力，全面地評估學生的表現；同時把學與教與評估結合，讓學生從教師的回饋中了解自己的強項與弱點。推行校本評核亦可減少對公開考試成績的依賴，有助提升學生自信心及學習興趣，鼓勵自主學習。  
SBA emphasises the assessment of a wide range of abilities which offers a comprehensive appraisal of students' performance. By integrating learning and teaching with assessment, it helps students understand their strengths and weaknesses through quality feedback from teachers. SBA also reduces dependence on the results of public examinations, boosts students' confidence and motivation to learn and enhances autonomous learning.
- ✎ 由2024年文憑試起，共有12個甲類科目設有校本評核。  
SBA will be implemented in 12 Category A subjects from the 2024 HKDSE onwards.

## 乙類 CATEGORY B

## 應用學習科目 Applied Learning (ApL) Subjects

- ✎ 評估學生對個別專業或行業的知識、理解和技巧。非華語學生可修讀應用學習中文（非華語學生適用），科目旨在為非華語學生提供額外途徑，獲取另一中文資歷，為升學及就業作好準備。

Assessing students' knowledge, understanding and skills related to a particular profession or trade. ApL Chinese (for non-Chinese speaking students) is introduced to provide an additional channel exclusively for non-Chinese speaking students to obtain an alternative Chinese Language qualification to prepare them for further studies and work.

- ✎ 不設公開考試，評核由個別課程提供者負責。

No public examination and the assessments are conducted by the respective course providers.

- ✎ 考生成績須經考評局審定，並於文憑試證書上匯報。

After moderation by the HKEAA, student's ApL results are recorded on the HKDSE certificate.

## 丙類 CATEGORY C

## 其他語言科目 Other Languages Subjects

### 2024年文憑試或之前 2024 HKDSE or Before

- ✎ 六個考試科目包括法語、德語、印地語、日語、西班牙語及烏爾都語。

Six language subjects are offered, including French, German, Hindi, Japanese, Spanish and Urdu Languages.

- ✎ 採用劍橋大學國際考評部（劍橋國際）的高級補充程度試卷。

Question papers of the Advanced Subsidiary level from Cambridge Assessment International Education (Cambridge International) are used for the examinations.

- ✎ 閱卷及評級由劍橋國際處理。

Marking and grading are conducted by Cambridge International.



### 2025年文憑試起 Starting from 2025 HKDSE

- ✎ 五個考試科目包括法語、德語、日語、韓語及西班牙語。  
Five language subjects are offered, including French, German, Japanese, Korean and Spanish Languages.

### 2026年文憑試起 Starting from 2026 HKDSE

- ✎ 其他語言科目考試增至六科，包括新增的烏爾都語，以及法語、德語、日語、韓語及西班牙語。  
The number of Other Languages subjects will increase from five to six, including the newly introduced Urdu Language, as well as French, German, Japanese, Korean and Spanish Languages.
- ✎ 考生於文憑試考試年份前的兩年內，自行應考由相關國家官方機構在港舉辦的指定語言考試。  
Candidates have to take the stipulated language examinations administered in Hong Kong by the official organisation(s) of the respective countries, within two years preceding the HKDSE the candidate sits.
- ✎ 考生成績達到指定最低的語言能力水平或以上，方可獲列入文憑試丙類科目的成績。  
Candidates' results obtained in these examinations at the stipulated minimum proficiency level or above will be included in the HKDSE Category C results.

# 成績匯報制度 The Reporting System

甲類  
CATEGORY A

## 高中科目 Senior Secondary Subjects

- ✎ 評級由考評局負責，採用水平參照成績匯報制度，各個科目參照一套明確而固定的標準，匯報考生表現所屬的等級。

The HKEAA is responsible for the grading of Category A subjects and Standards-referenced Reporting is adopted to report candidates' assessment results with reference to a set of explicit and fixed standards of performance.

- ✎ 除公民與社會發展科外，考生的表現以五個等級（1–5級）匯報，以第5級為最高。在第5級考生中，成績最優異的可獲評為5\*\*級；成績次佳的可獲評為5\*級；其餘的則評為5級。表現低於第1級的水平定為「不予評級」。

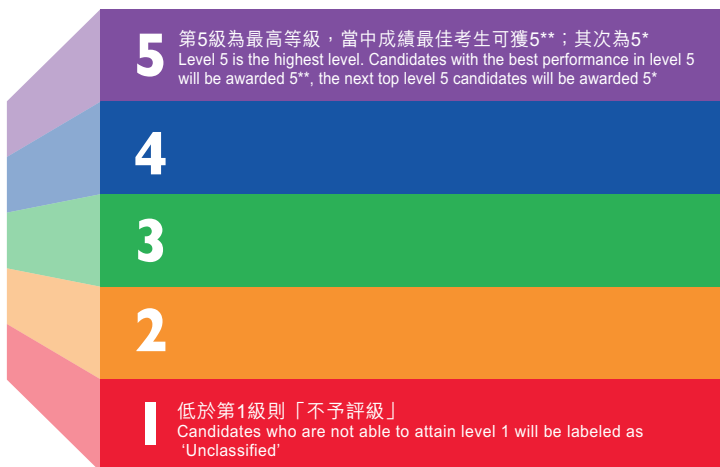
Except for Citizenship and Social Development, candidates' performance is reported in five levels (1–5), with 5 being the highest. The highest-achieving level 5 candidates are awarded level 5\*\*; the next highest-achieving level 5 candidates are awarded level 5\* and the remaining level 5 candidates receive simply level 5. Performance below the level 1 standard for a subject is designated as 'Unclassified'.

- ✎ 公民與社會發展科的成績匯報只設「達標」一級，成績在「達標」以下則以「未達標」標示。

The results of Citizenship and Social Development are reported in one level, 'Attained'. Achievements below 'Attained' are designated as 'Unattained'.

- ✎ 「不予評級」或「未達標」的成績，均不會在文憑試證書上匯報。

Results designated as 'Unclassified' or 'Unattained' will not be reported on the HKDSE certificate.



考生在甲類科目（公民與社會發展科除外）的表現以五個等級匯報  
Candidates' performance in Category A subjects (except for Citizenship and Social Development) is reported in five levels

- ✎ 除應用學習中文課程（非華語學生適用）外，應用學習科目以三個等級匯報成績，包括「達標並表現優異（II）」、「達標並表現優異（I）」及「達標」。表現低於「達標」的水平會被定為「未達標」，並不會在文憑試證書上匯報。

Except for ApL Chinese (for non-Chinese speaking students), three levels of performance are reported including 'Attained with Distinction (II)', 'Attained with Distinction (I)' and 'Attained'. Performance below 'Attained' is designated as 'Unattained' and is not reported on the HKDSE certificate.


- ✎ 應用學習中文（非華語學生適用）則設兩個等級匯報成績，即「達標」和「達標並表現優異」。

For ApL Chinese (for non-Chinese speaking students), there are two levels of results, i.e. 'Attained' and 'Attained with Distinction'.




考生在乙類科目（應用學習中文課程除外）的表現以三個等級匯報  
Candidates' performance in Category B subjects (except for ApL Chinese) is reported in three levels

**2024年文憑試或之前 2024 HKDSE or Before**

 成績以五個等級（a–e）在文憑試證書上匯報，以e級為最低，a級為最高，而e級以下的成績將列為「不予評級」，並不會在證書上匯報。

Results are reported in five grades (a–e) on the HKDSE certificate, with grade e being the lowest and grade a being the highest. Achievements below grade e are designated as 'Ungraded' and are not reported on the certificate.

**2025年文憑試起 Starting from 2025 HKDSE**

 各官方語言考試設有不同的成績匯報制度，考生成績若達到指定或更高的語言能力水平，便會獲列入文憑試證書為丙類科目成績。

Different reporting systems are adopted by the official language examinations. Candidates' results obtained in these examinations at the stipulated proficiency level or above will be included in the HKDSE Category C results and reported on the HKDSE certificate.

# 文憑試資歷認可 Recognition of the HKDSE

## 本地高等院校 Local Tertiary Institutions

考生在文憑試的中國語文科與英國語文科達到第3級，數學科必修部分達到第2級，以及公民與社會發展科取得「達標」的成績（簡稱「332A」），便符合資格申請修讀大學教育資助委員會資助的大學和院校的學士學位課程。除了四個核心科目外，各院校仍會制定選修科目的成績要求及其他入學條件。

Candidates taking the HKDSE have to attain a minimum of level 3 for Chinese Language and English Language, level 2 for Mathematics Compulsory Part and 'Attained' for Citizenship and Social Development (i.e. '332A'), in order to meet the minimum requirements necessary to apply for the undergraduate programmes offered by the University Grants Committee funded institutions. Apart from the four core subjects, institutions will also set the requirements for elective subjects and other admission requirements.

## 非本地高等院校 Non-local Higher Education Institutions

除本港的大專院校外，文憑試獲數以百計的內地、台灣及海外高等院校認可，直接以學生的文憑試成績考慮其入學申請。

The HKDSE is well recognised both locally and globally. Hundreds of higher education institutions from the Mainland, Taiwan and overseas accept the HKDSE results for admission.

## 資歷級別 Qualifications Framework Level

香港中學文憑屬於香港資歷架構第三級的資歷水平，本地僱主進行招聘時，一般會以文憑試成績制定入職要求。香港特別行政區政府公務員事務局亦承認文憑試資歷符合相關政府職位的基本入職要求。

The HKDSE is recognised under the Qualifications Framework (QF) in Hong Kong as meeting the accreditation standards at QF Level 3. It is common in Hong Kong that employers will set job requirements with reference to results in the HKDSE. The Civil Service Bureau of the Hong Kong SAR Government also accepts the results in the HKDSE for civil service appointment purpose.
