Inclusion of Hindi Language in Category C Other Languages Subjects for 2028 HKDSE and Beyond

The Hong Kong Examinations and Assessment Authority (HKEAA) announced today (1 December 2025) that an agreement has been signed between the HKEAA, the Central Hindi Directorate of the Ministry of Education in India (CHD), and the Consulate General of India, Hong Kong and Macau SARs (CGIHK) for the inclusion of the 'Advance Diploma in Hindi Examination' as the stipulated Hindi Language examination under the Category C Other Languages subjects, starting with the 2028 Hong Kong Diploma of Secondary Education Examination (HKDSE).

Prof Wei Xiang-dong, Secretary General of the HKEAA, stated, 'The HKEAA is grateful to the CGIHK for facilitating this examination arrangement, which addresses the needs of the Indian community in Hong Kong, as well as the schools and students involved. Since the implementation of the new examination arrangement for Category C Other Languages subjects in 2025, the arrangement has received support and recognition from schools, candidates, and official examination bodies. We will continue to provide a broad, balanced, flexible and diversified suite of examinations to meet the varied needs and interests of our candidates.'

According to the new examination arrangement for Category C Other Languages subjects, candidates should take the stipulated language examinations administered in Hong Kong, and their results at the stipulated minimum proficiency level or above will be included in the HKDSE Category C subject results. Six subjects are offered in the 2026 HKDSE, including French, German, Japanese, Korean, Spanish and Urdu Languages.

The 'Advance Diploma in Hindi Examination' is administered by the CHD, and the CGIHK will be responsible for conducting the examination in Hong Kong. The first examination is scheduled for May 2026. Its results are reported across four levels, from the lowest: 'Pass', 'Second Division', 'First Division', and 'Pass with Distinction'. Starting with the 2028 HKDSE, the number of Category C Other Languages subjects will increase from six to seven, enabling candidates to choose Hindi Language as one of these subjects. Candidates should submit their registration forms along with necessary documents to the CGIHK for the 'Advance Diploma in Hindi Examination' according to its examination schedule. They should complete the examination within two years preceding the HKDSE they sit (for example, for the 2028 HKDSE, candidates may take the examination between 2026 and 2027). Candidates attaining a Pass or above in the examination will have their results included in the HKDSE Category C subject results. The 2028 HKDSE

examination regulations have been revised to reflect the corresponding changes. Further details about the examination are listed in the Annex.

The HKEAA has also actively promoted the HKDSE qualification to the Indian higher education sector, supporting students learning Hindi in pursuing further studies in India and broadening their pathways. The Association of Indian Universities (AIU), which represents over 1,000 higher education institutions in India, has recently confirmed that the HKDSE qualification is considered equivalent to India's high school graduation qualification (Grade 12), allowing candidates to apply directly to Indian higher education institutions and universities with their HKDSE results.
